Article 1 - Corporate Name

Article 5 - Purpose

The corporation is organized for the following purpose or purposes:

This nonprofit corporation is established to provide free introductory and affordable continuing swing dance lessons to San Antonio and its surrounding area. The corporation will also increase the awareness and recognition of swing dancing through public demonstrations, open dance socials, workshops, and information open to the public on where and when to find swing dance venues.

This nonprofit corporation will be limited to the any lawful purpose or purposes not expressly prohibited under chapters 2 or 22 of the Texas Business Organizations Code, including any purpose described by section 2.002 of the

Code.

Said corporation is organized exclusively for charitable and educational purposes, including, for such purposes, the making of distributions to organizations that qualify as exempt organizations under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code.

Supplemental Provisions / Information

The corporation will distribute nonprofit assets in accordance to section 22.304 of the Texas BOC.

Additional Limitations of Purpose and Distribution

No part of the net earnings of the corporation shall inure to the benefit of, or be distributable to its members, trustees, officers, or other private persons, except that the corporation shall be authorized and empowered to pay reasonable compensation for services rendered and to make payments and distributions in furtherance of the purposes set forth in Article Five hereof. No substantial part of the activities of the corporation shall be the carrying on of propaganda, or otherwise attempting to influence legislation, and the corporation shall not participate in, or intervene in (including the publishing or distribution of statements) any political campaign on behalf of or in opposition to any candidate for public office. Notwithstanding any other provision of these articles, the corporation shall not carry on any other activities not permitted to be carried on (a) by a corporation exempt from federal income tax under section 501(c)(3) of the Internal Revenue Code, or the corresponding section of any future federal tax code, or (b) by a corporation, contributions to which are deductible under section 170(c)(2) of the Internal Revenue Code, or the corresponding section of any future federal tax code.
